### **Purpose & Function**

#### **Method of Selection of Members**

The faculty member is elected by the Executive Committee of the Faculty Senate.

The undergraduate students are appointed by the Executive Board of the Student Council in consultation with the Vice President for Enrollment Management and Student Success.



The graduate students are appointed by the President of the Graduate Student Council in consultation with the Vice President for Enrollment Management and Student Success.

The remaining members are ex officio.

#### Selection of Chair and Vice or Co-Chair

The Chief of Campus Safety is the Chair of this University Standing Committee.

#### Term

Faculty – two-year unlimited terms

Students - one-year unlimited terms

Meetings are held at least twice each academic year.
